Subject: Approval of Alaska Electric Vehicle Infrastructure Deployment Plan

Dear Commissioner Anderson:

The Federal Highway Administration (FHWA) has completed the review of the Alaska Electric Vehicle Infrastructure Deployment Plan required under the National Electric Vehicle Infrastructure (NEVI) Formula Program.<sup>1</sup> Based on the review and the recommendations provided by the Joint Office of Energy and Transportation (Joint Office), FHWA has determined that the Alaska Electric Vehicle Infrastructure Deployment Plan is approved for implementation. With this approval, Fiscal Year 2022 funds are now available to Alaska for obligation.

The following table details exceptions that were requested in the Alaska Plan and the approval determinations by FHWA.

| Location                       | Type                        | Determination                |
|--------------------------------|-----------------------------|------------------------------|
| AK-3 Trapper Creek to Cantwell | 50-mile in between stations | Approved: valid for one year |

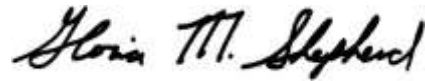
